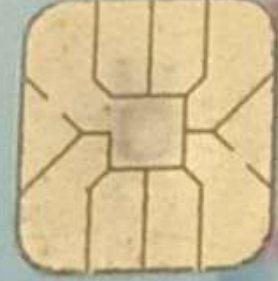

Appointment on Contract
